

New York Apple Specs Export Specs – Vietnam

- Pack to fruit size and case requirements of the customer.
- WAX – Carnauba **or Shellac**
- Imperative to remove any punctures / decay - can get worse in 1+ month transit
- Pallets - Heat treated (stamped HT) pallets – do not need to be block
- SmartFresh (MCP) treated
- Pressure - Firm 15# pressure minimum
- Grade Standards by Variety:
 - Empire: Combination US Extra Fancy / US Fancy grade
 - SnapDragon: CTAG SnapDragon Packing Specs
 - KORU: Coast to Coast KORU Packing Specs
- PLU – Yes, but does not need to be Databar
- Import permit needed– Yes
- Ag&Markets inspection - Yes
- Phyto Yes – list exact address as on Import Permit
- Paperwork - send to NYAS office / Lynda
- Temperature recorder – 40 day
- Corner post and strap Yes
- Seal Yes
- Inquire if photos of fruit, box end, and box to be sent to customer
- Shelf life test – save apples until after fruit arrives – approx. 30+ days
- **Lids: No lids required**

Cartons must be labeled with:

- ✓ Product description
 - e.g. Apples - Empires Comb US Ex Fcy & US Fcy xx count
- ✓ Product of USA – country of origin
- ✓ Lot Code - which includes packhouse alpha-prefix
- ✓ No weight statement on cartons other than that which is already printed on the Vietnamese sticker label.
