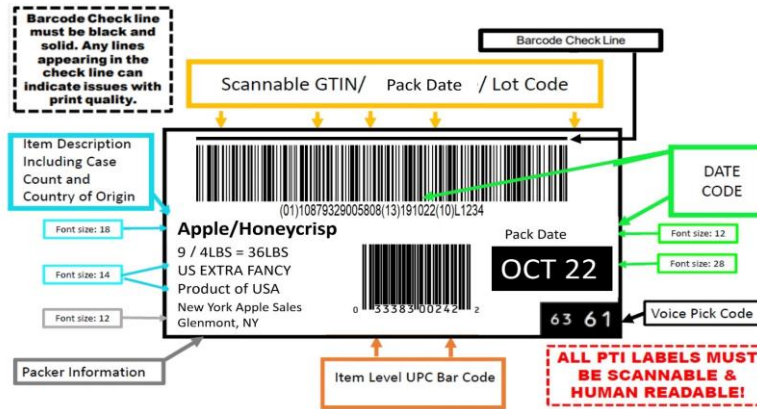

Pouch bags must be packed laying down in the box, not standing up.

Notes:

- Fuji - Must not have more than 20% severe water core
- Go Wireless temperature recorders are required
- Any new bags ordered need to have 2 UPCs
- Seals are required
- ASN Pallet Tags are required
- Corner boards required

Program Execution

- Temperature recorders must be accompanied by orange "Temperature Monitoring" placards (inserts) supplied by Emerson to indicate the location of each recorder.
- Place placard with sensor on face of pallet, 2-3 feet down from top, on the right or left side away from chutes discharge area.
- Do not place sensor on trailer wall, and avoid placing sensor facing trailer door on the tail of the trailer.
- Avoid placing sensor horizontally on top of pallet.
- All temperature recorders placed on inbound shipments are **required** to be linked to their corresponding PO# in Emerson's system (see instructions, demonstrator and the Emerson Portal at <https://climate.emerson.com>).



Where To Put the PTI Label?

- All PTI labels going forward will need to be located on the top corner below the variety of the short side of the box.
- Must be placed on the outward facing end of box when palletized.
- Uniform location will help with proper PTI label identification.
- When possible avoid placing over member facing front panel.

ASN PALLET TAGS

Each pallet must be labeled on two adjacent sides and affixed to the top right-hand corner inside the shrink wrap

**Gala AND Honeycrisp pallets - please put cardboard caps over each pallet as shown above.

Effective February 6th, 2023, Sam's Club will bill suppliers for costs incurred due to shipping product with a UPC that does not match item data records in our Item File.

For each instance, packhouses will be billed \$950.36 (HO costs) for each affected item plus \$69.25 per club in an actively replenished status.

*Note: these fees do not include any additional labor costs incurred for relabeling product (if needed)
