Temperature recorders and seals required on all loads. Go Wireless recorders are required. Receiving pulp temps **33-40** (Aug-Oct 60 degrees). **PLEASE CHECK PULP TEMPS**. Weights must meet or exceed weights printed on package. Pallets must be shrink wrapped or strapped/corner posted from top to bottom. PLU, UPC and GTIN's need to match exactly, Accepted A- if they do not scan. RPCs preferred. Grade XF.

IFCO RPCs are required. If IFCO RPCs are not available please use corrugated cartons. Send NYAS the quantity for Walmart exception approval. Lids are required on corrugate cartons.

**Target Wax Coverage: 100% (allowed up to 10% under target)**

**Go Wireless Temp Recorder**

Temperature recorders must be accompanied by orange "Temperature Monitoring" placards ("Find it Inserts"), supplied by Emerson, to indicate location of each recorder. Place placard, with recorder, on face of the tail pallet for every shipment, approximately 2-3 feet down from top of pallet on the right or left side away from the chutes discharge area. Use similar placement for additional recorders placed on loads (see picture below).



USDA Watercore Guide

BAG NOTES
UPC must be printed on all bags. up to \$10,000 fine for wrong UPC. Stickers on bags need to be on the back corner. Kwik lok bag closures are required. 2 1/2" min. diameter consistent in size with no more than 1/4" variance. <b>No PLUs on bagged apples.</b>
BULK NOTES
GTIN omni stack barcoded PLU is required. 95% stickered fruit.
TOTE NOTES
No Fuji/Gala/Granny Smith/Honeycrisp/Red Delicious apples in totes. 2 1/4" min to 3" max diameter (limit 3 sizes in a bag). 1 colored sticker is required on the front of the bag with <b>UPC# &amp; PLU#</b> . No 1/2 peck notation. 35 cases per pallet. <b>Add 2 extra empty tote bags to each case.</b>
